1) All fish must be caught on hook and line in on a Boulder Junction township lake or river during the legal season for fishing on boundary waters. Must be legal size fish species for the water body fished.

2) Measurements: The "girth" is measured at the widest spot on the fish. The "length" must be measured in a straight line from the tip of the snout to the end of the compressed tail.

3) All entries must be registered on an Official Registration Form (only one fish per form). Entry forms are available at Northern Highland Sports, the Boulder Junction Chamber of Commerce and **www.boulderjct.org**. Entries should be completed IN FULL, witnessed and submitted to:

4) A photograph of released fish will be required for a registration to be considered for any of the prizes offered. Released fish registrations submitted without a photograph will not be considered complete and will not be considered eligible for any prizes issued by the contest. Any false verification of entries will disqualify person or persons involved in all current and future Boulder Junction Fishing Contests.

5) Kept fresh (not frozen) fish must be weighed in at Northern Highland Sports. No photograph is required.

6) Required photographs must be submitted with entry form on the last day of the month the fish was caught in order to be considered eligible for prizes. Photos can be mailed or emailed to boulderjct@boulderjct.org and will not be returned.

7) Contest begins opening game fish weekend (the first weekend in May) and ends November 30th.

8) Prizes will be awarded to all species on the 1st of the month beginning June 1st. Annual prizes will be awarded to all species in December.

9) Decisions on interpreting, accepting or rejecting a registration are the sole discretion of the Boulder Junction Chamber of Commerce.
