## **Booth Fees:**

Early Bird rate: \$85/booth if post marked by February 1, 2022

Standard rate: \$95/booth if post marked after February 2, 2022

All booths are 10' deep and 10' wide.

**NO REFUNDS will be given after juried acceptance. The show will be held rain or shine.**

## **Acceptance/Jury Procedure:**

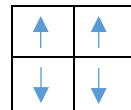
This is strictly an arts and crafts fair. Exhibitors must display and sell only their own handcrafted items. **All exhibitors are required to submit photos with their application.** Please submit three photos of your work, one of you at work and one of your booth display. Submitted photos will be returned with notification letters. Exhibitor applications without photographs will not be accepted. All applications must be signed and include your booth fee. See fee schedule for cost. **Past exhibitors submitting their application by February 1<sup>st</sup> will be honored the same booth location as last year. We cannot guarantee location after the deadline.** A map of your booth location will be sent along with your letter of acceptance. NO REFUNDS will be given after acceptance.

## **Rules:**

**Eligibility:** Artist/Crafter must be present the day of the show. Work must be of original concept, design and execution, no kits, commercial molds, etc. Photos submitted for jurying must be representative of the majority of the work to be exhibited. Jurors will use booth photos to judge the overall appearance and make-up of your display. An exhibitor found selling store merchandise, manufactured items, purchased crafts, etc.; will be evicted from the show.

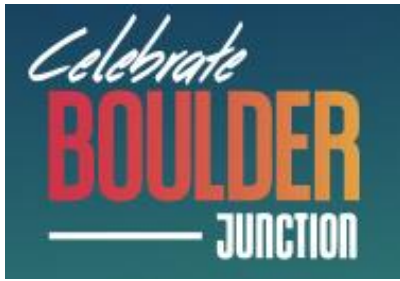
**Exhibits:** The Arts and Crafts Fair is held outdoors on our wide paved, Main Street. Booths will be in clusters of 4 with 15' walkways on Main Street and 20' walkways on Hwy M. Exhibitors must supply their own canopies, tables, etc. **Awnings are acceptable; however, all merchandise must be displayed within your 10'x10' allotted space. Exhibitors with merchandise overflowing outside of the 10'x10' booth need to purchase a double booth in advance.** Show is on rain or shine. Electricity is not available to any booth. Food products must be prepacked. Thank you!

**Display Hours:** 9:00am to 4:00pm. All booths may start set-up at 5:00am and must be ready to operate by 8:45am. All booths must be in operation until 4:00pm. Exhibitors removing items prior to 4:00pm will not be invited to exhibit in the future.



**Parking:** All vehicles must be moved off Main Street by 8:00am. Free parking is available on some of the side streets and off Marsh Road. Please see a Chamber volunteer for questions regarding designated parking areas.
