Acceptance Procedure

This is strictly an arts and crafts fair. Exhibitors must display and sell only their own hand-crafted items. Past exhibitors (from 2021 or 2022) are not required to submit photographs. New exhibitors are required to submit photographs with their application. Please submit three photos of your work, one of you at work and one of your booth display. New exhibitor applications without photographs will not be accepted. All applications must be signed and include your booth fee. See fee schedule for cost. Booth fee will be returned if not accepted.

Rules

Eligibility:

Artist/Crafter must be present the day of the show. Work must be of original concept, design and execution; no kits, commercial molds, etc. An exhibitor found selling store merchandise, manufactured items, purchased crafts, etc.; will be evicted from the show.

Exhibits:

The Arts and Crafts Fair is held indoors at the Community Center and out of doors at the Community Center Pavilion & Grounds. Exhibitors must supply their own canopies, tables, etc. (unless indoor table rental is requested with this application). This is a rain or shine event. Electricity is not available to any booth. A map of your booth location will be sent along with your letter of acceptance.

Display Hours:

9:00am to 3:00pm. All booths may start set-up at 7:00am and must be ready to operate by 9:00am. All booths must be in operation until 3:00pm. Exhibitors removing items prior to 3:00pm will not be invited to exhibit in the future.

Parkina:

All vehicles must be parked in designated area by 8:45am. Please see a Chamber volunteer for questions regarding designated parking areas. Outdoor booths may keep their vehicles behind their tents.
